## POOL REGULATIONS

Homeowners and Guests swim at their own risk. Members are responsible for the conduct of their guests. The Birdsong Estates Neighborhood Association is not responsible for accidents or loss of personal property within this property.

## POOL ACCESS

Access to the pool requires a key and a Birdsong Estates Pool Pass with a unique identification number assigned to each resident. Random checks will be conducted by the Homeowners Association Board Members. Any persons in the pool area who do not have a valid pool pass will be asked to leave the pool area immediately. Any guests of that person will be asked to leave, also.

Replacement pool passes and keys are available for a fee of \$10 each. When a pool pass is replaced, the previous number will be marked as invalid. Any person trying to use an invalid pool pass will be asked to surrender the pass and leave the pool area immediately.

## POOL MAINTENANCE

Pool maintenance is currently scheduled for every Tuesday morning. There may be times the pool will not be available at 9:00 AM on Tuesdays due to dispersing of chemicals that can be harmful until they have had time to circulate. A sign will be posted on the gate stating the time the pool will be available for use in such a situation. This is for your safety. Please adhere to the time stated on the sign. Birdsong Estates is not responsible for injuries resulting from disregarding the posted time.

## POOL RULES VIOLATIONS

Gross violations of the rules below will result in the pool being closed by the Homeowners Association Board Members for an unspecified amount of time. It is your duty as a resident to help police the pool area and ask those violating the rules to stop. If they refuse, please contact a Homeowners Association Board Member for assistance.

## POOL RULES

These rules are in place for your safety and well-being, not to decrease the amount of fun you can have at the pool. We must adhere to these rules.

1. All persons under the age of 16 shall be accompanied by a parent or an adult over the age of 18 while at the pool area.
2. There will be no running or horseplay in the pool area at any time.
3. The safety rope must be attached at all times. No standing, sitting, pulling, or playing on the rope. Failure to have this rope in place can result in our pool being shut down by the health department.
4. Swim gear must be worn by anyone using the pool.
5. The clubhouse bathroom may be utilized by swimmers in swimming attire, but no other portion of the clubhouse will be used by swimmers in swimming attire. All small children shall be accompanied by an adult when using the bathroom. The outside door to the bathrooms must be left closed and unlocked.
6. Pets are prohibited in the pool area.
7. Profanity will not be tolerated, including music with explicit lyrics.
8. No glass containers are allowed in the pool area.
9. Trash must be deposited in the trash receptacle. Cigarettes should be deposited in the cigarette receptacles. Members using the pool area are responsible for cleaning any soiled area during their use of the pool facility. Umbrellas should be closed upon leaving the pool area.
10. Number of guests is limited to four (4) per household. Exceptions to this rule for special circumstances can be requested. Requests should be made to the Homeowners Association Board Members.
11. Entrance to the gate must be kept locked at all times.
12. Guest must be accompanied by a Birdsong Resident.
13. No loud music allowed.
